#### MINUTES

Behold! God is doing a new thing! He is giving people a fresh start, a brand new life with Jesus!

As the Apostle Paul writes, "If anyone is in Christ, the new creation has come: The old has gone, the new is here!"

For many years, I've prayed that the church would resemble, more and more, the crowd that followed Jesus. Those desperate ragamuffins who came to Jesus, weary, rejected, and unable to save themselves... yet, holding out hope that God's grace might be available to them.

I think that's happening at College Church.

Lord my God, I called to you for help, and you healed me. -Psalm 30:2

That may be His favorite song of all!

### Letter from the Elders

Dear College Church family,

The Elders praise God for such an amazing year at College Church. While we celebrated regathering together indoors for worship and re-establishing many of our traditions and rhythms last year, this year we began moving forward into fresh ground as a church, engaging our neighbors and community on several important fronts in the name of Jesus and for His sake.

We celebrate that College Church repeatedly demonstrated an ability to have difficult conversations and still experience unity. We had a large and successful gathering last fall to explore the Elders position paper on Racial Justice and Embodied Reconciliation. That meeting generated ideas which led to several new initiatives, among them: a presentation by two historians on Jonathan Edwards and the history of slavery in Northampton, we did a screening of the movie Harriet, held a GROW Class on Racial Difference, heard parts of MLK's Letter from a Birmingham Jail read at the Coffee House, and sat at the feet of an African American Preacher, Minister Pamela Fox, from Urban Promise. We are grateful.

Further demonstrating our ability to have difficult and challenging conversations, in late fall, 70 leaders from various College Church ministries gathered for a weekend of Posture Shift training with Bill Henson and his team to learn how to better understand, nourish faith identity in, and radically love LGBT people.

In the spring, with our budget deficit growing rapidly from a decline in contributions, what was a concerning challenge became a great blessing in God's hands. We held a series of House meetings where we shared again the vision we have to fulfill Jesus' Great Commandments and Great Commission, right here in the Pioneer Valley. Your response was overwhelmingly generous, and we are still aglow in the joy of that experience. It is because of your faithfulness that we were able to bring forth the budget we have at this annual meeting. Also, another great benefit of the house meetings was the plethora of ideas, suggestions, and constructive feedback which we captured and are planning to explore further.

We have enjoyed watching how God is moving at College Church and have prayerfully encouraged the launch of new ministries this year, such as the Care Team (to support those with disabilities and their caregivers) and Recovery Church. We see the launch of these ministries at College Church as a good sign of the Spirit's work in our midst! We also are grateful for the addition of Naomi Desilets to our staff team, and the work she is doing to cultivate partnerships and to mobilize us to serve our neighbors.

Finally, we have seen more benefits from enhancing the role of the Shepherds and are grateful for their knowledge and spiritual insights at elder meetings. We look forward to continued growth in the leader-ship and ministry capabilities of College Church, especially as the Lord continues to bring us in touch with more people at various stages of their spiritual journey.

### Letter from the Deacons

Dear College Church Family,

It was another rewarding year for the Deacon Board in serving the Congregation. Our eight-member team included the blessing of two new members. The Board met monthly as a whole, and smaller meetings occurred as needed to meet the needs of the Congregation. The Board nominally operated as three groups, or teams, handling visitation requests, financial requests, and all other needs. In addition to our normal business, the Board revised our Deacon Manual to better clarify our mission, expand our provision opportunities, and provide year-over-year consistency as Board membership evolves.

Maintaining community with those unable to travel freely is a principal care of the Deacons. The Visitation Team provided outreach in homes, hospitals, assisted living homes, and/or on the phone if that was what suited best. The Deacon's underwent training from the Elders to offer Communion during visits after it was identified as an important need for some. The team attempted to have two Deacons participate in each visitation after finding it more naturally blossomed deep and meaningful conversation. Due to the nature of many relationships in a smaller church like College Church, Deacons were oftentimes unsure if they were visiting as friends or as Deacons; that is exactly the sort of thing that is a blessing and doesn't need to be labelled.

The Deacon's mission includes assisting short term financial needs. The Casework Team prayerfully contemplated each financial request that came to the board. Typically, a few deacons meet with person(s) seeking support to sensitively discuss their current needs and resources, and to determine how we can best help. Sometimes that goes beyond offering financial assistance to providing links to federal/state benefits and other community resources. We assisted in food, housing, furnishings, and emergency related expenses. The Congregation's continued generosity has maintained the Deacon Fund throughout the year. We are well positioned to continue meeting the financial needs as they arise into next year.

If a request doesn't obviously fall into the categories of Visitation or Casework then Helping Hands is the answer. The Helping Hands team mobilizes the Congregation-at-large to meet the practical needs of others in the Congregation. The annual Helping Hands survey provides guidance on the skills and resources available in the Congregation to assist others from time-to-time. This year Helping Hands helped match people for meals, transportation, and various needs around the home.

We thank the Congregation for the privilege of serving the church. It's a special opportunity to make new relationships and grow existing ones. In our monthly meetings we focus on devotion, prayer, needs, and actions. Last fall the Deacon's shared in a day long retreat. It was a wonderful time where we delved into what it was to be a Deacon, listened to the Lord, and deepened our relationships. We were invited to spend time and eat pizza and fruit with the Youth Group twice this year. We assisted the funeral committee in their memorial service, and helped serve breakfast during Holy Week. The title of Deacon is temporary for each of us, but the heart of a Deacon is present always. The church is blessed with many people who harbor the heart of a Deacon.

### **Community Partnership**

Dear College Church,

What an exciting 8 months it has been! It is hard to believe that a year ago when the last Annual Report came out I was a new transplant to Northampton and wasn't on staff yet. What a whirlwind of a year it has been! First, a word of thanks to everyone who has warmly welcomed me and come alongside me as I've taken my first steps in this new role. My heart is overflowing with thanks for y'all!

If you joined us at one of the recent Vision meetings you got to hear a bit of a preview of this report. Some highlights of the year have included:

**Coffee with a Cause:** In April we held our second Coffee with a Cause! Thanks again to everyone who baked, performed, helped set up and clean up, and ran sound and technology. With your help we raised \$900 that went to benefit The Northampton Survival Center and local refugee resettlement.

**Straight Ahead**: This year we partnered with Straight Ahead to connect with the RFK House in South Hadley to provide Christmas gifts for teenagers in lock-up, as well as started an ongoing partnership to provide toiletries for the house. I am constantly blown away by your generosity! The trunk of my car is constantly full of donations from College Church to give to our partners!



**Grace House:** For Christmas the youth group baked desserts and wrote cards for the women at Grace House, a residential treatment program for mothers in recovery and their children. Our youth are AMAZ-ING bakers!

Weekend Backpack Nutrition Program: I have joined the steering committee for the new pilot program to provide food for food insecure children at Bridge St School. The committee consists of members from other churches, and we hope to launch the pilot at the beginning of the school year! The pilot was one of the projects chosen by the Mayor's office to receive ARPA funds, which will cover the costs of the first 3 years of the project. The program will have 3 parts: (1) provision of weekend packs of non-perishable breakfast and lunch items, received at elementary school each Friday; (2) grocery cards (if chosen in lieu of the food packs) to supplement family weekend food budgets with fresh foods that families know their children will like; and (3) an 8-week crock pot cooking program for middle/high school-age students to teach basic culinary skills, instill patterns of healthy eating, and supply a weekend family meal. As we get the project up and running there will be many different opportunities to serve and get involved! Stay tuned!

**Resilience Hub:** Pastor Bill and I have begun gathering with clergy from the other Northampton churches to discuss how churches can get in on the ground floor and be involved with the new Resilience Hub. Plans for The Resilience Hub have been in the works since 2019, and the vision is finally coming to fruition! The hub will support the daily needs of those experiencing homelessness and extreme poverty, as well as serve as the consolidated entry point for the distribution of resources and connection to services. Our group recently met with the Mayor's chief of staff, and in the coming weeks will be meeting with Community Action, the nonprofit that will oversee daily operations of the hub, to continue the conversation. Currently the hub is expected to be open to the public before the snow falls!

Looking ahead, we have exciting new opportunities coming down the Pike! We hope to host some build days with Habitat for Humanity, find opportunities for small groups to serve together, launch the Weekend Backpack Nutrition Program, and assist with the transition and launch of the Resilience Hub.

It is a joy to work together to partner with our community to serve our community!

### Worship Arts & Tech Team

This past year of serving as the Worship Arts Director has been exhilarating! Last year, I wrote, "I have the wonderful opportunity to experience great unity across generations and varied experiences through music, which I find to be a rare gem in these polarizing times." This continues to be true, as the worship team has grown into a rare mix of people from all walks and stages of life. There is now a rotating team of over 25 musicians who play at least once a month, spanning about 60 years of age difference. The growing number of dedicated volunteers has made it possible for me to shift into a hybrid role, splitting my time between youth ministry and worship arts. After over 2 years of being live and on stage almost every Sunday, I have shifted into a rhythm of leading worship 2-3 times a month, singing as part of the congregation on the other weeks. David and Karen Damsky, Melanie Lamere, Connie Schwaiger and Christina Jones have graciously stepped in to form a core group of worship leaders, allowing me to hand off the set list and entrust the team to them each month. I have to say, this shift has been one of the greatest gifts of 2023. Praise be to God for His Body in action!

Pastor Bill and I, at the beginning of each sermon series, make it a habit to sit down and think through what songs would weave with and magnify the teachings of the series. Every time, we find ourselves lamenting the lack of we/us songs as we wade through the countless "me & God" tropes that dominate Contemporary Christian Music. As I'm sure you know, the Bible frequently charges Christians to sing to one another "in psalms, hymns and spiritual songs" (see Ephesians 5:19, for example). Songs like "Is He Worthy?" and "Your Burden is Mine", which have now been incorporated into our regular worship, invite us to do that. It feeds my soul when I hear the congregation reminding each other of God's good truth. I want to add, some of our most beloved songs have come from the congregation, so please provide suggestions as you feel led!

Celebrating special holidays continues to be joyful. This year we continued to sing and meditate on Jesus' life and death through our Holy Week devotions, which have fast become my favorite way to pause and contemplate, providing a moment to breathe in the busyness of the spring. We gathered on Maundy Thursday to marvel at the Lamb of God, culminating in a slower paced communion and nailing of our burdens and sins before the cross. This year, we've done two fun outros for both Christmas Eve and Resurrection Sunday, leaving the congregation tapping their toes to "Go Tell It On the Mountains" and "When We All Get to Heaven."

This year, we were able to attend a New England-wide worship conference called Simply Worship at Lifepoint Church in Chicopee. I, along with eight College Church worship and tech team members, had the opportunity to learn from seasoned music and tech team leaders and join other worshippers in singing to our God. We also had the chance to hear from Paul Baloche, most famously known for his song, "Open the Eyes of My Heart Lord."

Many of you already know this, but I have made the decision to step down from my staff role, effective July 1. While it was a tough decision, I trust that this is how God is leading me, and I feel confident stepping back when there is such a robust team with strong, committed leaders. I find myself reminiscing all the more about my early days with College Church in the Fall of 2020, when there were very few of us, masked and in person, doing our best to sing with you through the camera. Today, my heart feels more full than ever before, as I prepare to hand off my role to a very capable team of volunteers. I will be taking a few months off from leading on Sundays, and I will return as a volunteer leader in the fall. Thank you for all your prayers and support! ### Youth Ministry

Like many churches around the country, our youth ministry is continuing to adapt to a post-Covid world.

A lot happens between 6<sup>th</sup> and 12<sup>th</sup> grades. Our dream for our students is that, as they grow, they will develop a Christ-centered identity, experience a deep sense of belonging to God's Family, and begin to discover how their lives connect to God's purposes in the world! To that end, we consider youth ministry *everything* that a church does to help students cultivate an identity, belonging and purpose anchored in Christ!

We continue to be grateful for the dozens of adults who came to youth group this year to connect with students over dinner. We're grateful for the small groups in our church that welcome students into rhythms of fellowship, worship and spiritual growth. We're grateful for the men and women who shared not only the gospel, but their lives, with our students this winter and spring—telling the stories of how God became real to them during their teenager years. And we're grateful for the many ministry leaders who are investing in and entrusting important ministry to students! You are a gift!

This year we adapted our gatherings on the 1<sup>st</sup> and 3<sup>rd</sup> Sundays of the month to include musical worship. We welcomed seven new students into the ministry, including three from our sister church, Stonybrook. We retreated to Monadnock along with students and leaders from both Stonybrook and First Baptist Amherst. Students brought *The Lion, the Witch and the Wardrobe* to life last summer through the Summer Theatre Intensive, took flying leaps outside their comfort zones at the Notch Visitor's Center Ropes Course, and helped share the love of Christ with moms in recovery and students in lock-up over the holidays.

We are grateful for many signs of growth among our students. Many of our students began praying out loud this year for the first time. Some of our students have pursued mentors to help them grow spiritually. At least one student is mentoring a younger student! A growing number of students are becoming integrated into the life of the church through intergenerational small groups, serving on various ministry teams, and embracing opportunities to travel cross culturally to be a learner, a servant and a witness to Jesus.

College Church has been blessed with an incredible youth worker team that is wonderfully present to our students, both inside and outside of church events. One of our youth workers recently told our students, "You are my high point of the week."

In May, we celebrated our graduating seniors: Westin Hellyar, Brennan Hodgeman, TJ Lamere and Marie Willems. Each of them has been a gift to our group over the years!



We also took time to thank and bless Haram who will be stepping back from her staff role and her place on the youth worker team after 2 ½ years. Haram has been such a gift to our students, and she will be missed! She plans to continue mentoring students outside of youth group and supporting the ministry in other ways.

We have three goals for the coming year:


- 1. To increase parent engagement and ownership

### **Missions Committee**

- 2. Exterior Hired Dostal Tree Service to remove trees from the south end of main bldg. which had become too large, trim the beech tree by the Glass House, and remove a dead tree on the front lawn.

The following projects are planned for the coming year:

- 1. Main Building Evaluate what additional roof repairs are needed to the front side of the building and start setting aside funds to accomplish them.
- 2. Limited renovation work in the K House first floor bathroom.
- 3. General cleanout of clutter in all 3 buildings.

Future projects that God is leading us to undertake in our service to his church and the community:

- 1. K House Continue first floor renovations starting with the bathroom. Chimney removals and complete roofing replacement started with kitchen renovation.
- 2. Glass House Roof replacement.
- 3. Continue to work with the office staff and design team on all building improvements.
- 4. Continue to systematically maintain or replace our 50+ year old plumbing, heating and ventilating equipment.
- 5. Keep up the exterior appearance of our buildings and grounds. We thank you for your support and encouragement during the past year and as always welcome any suggestions you may have to help us in making our campus safe, comfortable, and attractive for the many ministries which normally take place here.

- 2014 Logan House Redecorated two upstairs rooms to accommodate interim pastor. Install acoustical sound board in sanctuary.
- 2015 Main Building Replaced 25-year-old Wheelchair Lift, and 2 additional boilers with 95 % efficient models. We now have 3 boilers replacing the previous five.
- 2016 Main Building Paint exterior and make heating and ventilating equipment repairs. Logan House - Fire alarm system upgrades.
- 2017 Sanctuary solar shades and complete Fire Alarm System upgrades in all three buildings to N F P A –
   72 with automatic communications to the Fire Dept.
- 2018 Install solar panels on the Main Building roof. Exterior wood restorations to Glass House followed by painting.
- 2019 Replace double metal exterior doors near upper-level handicap parking. K House kitchen renovation including chimney removal, partial reroofing, complete make over of interior including addition of an electric fireplace.
- 2020 Fellowship Hall—Mini-splits installed to provide A/C and heat.

Logan House – New flooring in kitchen and dining room.

K-House—Total renovation of entry-way / kitchen

2021 Main Building – New metal lower-level entrance door. Restoration of downstairs rooms and hallway from water damage in November 2020 storm.

### **Treasurer's Report**

This is the Treasurer's Report for the fiscal year June 1, 2022 through May 31, 2023; including the giving and expenses of The College Church Inc. for the general fund and restricted funds.

We are grateful to the Lord for all who gave to the ministries at College Church. Giving to the general fund increased slightly more than 1% (approximately \$6K) for the year compared to the previous year. Including the giving to a one-year restricted Building Fund that was approved along with the budget at the last annual meeting, giving increased by 2%, or \$11K for the year. The yearly budget for the year just completed, was an 8% increase from the previous year. So even with the increase in contributions, giving was below budget by \$36,167. Thankfully, expenses were lower than budget during the year; but expenses still exceeded giving by \$17,048. In nine of the last ten fiscal years at College Church, giving exceeded expenses by small margins, a healthy financial indicator which provided a balance in the general fund. Therefore, the general fund balance was adequately able to cover the deficit between giving and expenses this past year. Giving varies greatly from week to week, and month to month during the year. During the last few years, giving from mid-December through mid-January is increasingly strong as printed in the end of month financial reports in the Sunday bulletin and Weekly Announcements.

Giving to all restricted funds exceeded \$1,000 per week for the second consecutive year, which is excellent. This past year, the three largest restricted funds receiving donations are the Deacon Fund, one-year restricted Building Fund, and Missions-related activities. Monthly support for our mission partners is 15% of the general fund, as stated in 'Introducing the 2023-2024 Budget' which is a separate page in the annual report.

The treasurer normally presents the budget at the annual meeting. In reality, the budget is the Board of Elders responsibility, and is approved by the Board of Elders before presentation at the annual meeting. The budget is created by estimating expenses by numerous individuals & committees who are stewards of funds the Lord provides at College Church. Creating a budget this year was particularly challenging: 1) The economy is moderately inflationary which increases expenses. 2) As mentioned above, giving was below budget in the year just completed. 3) There was a desire to fill two-part time positions to assist in supervision, nurturing, and providing ministry at the church. There were House Meetings this spring to explain and discuss the opportunity and vision. From autonomous pledge cards received after the House Meetings, there was slightly more than \$50,000 that was pledged in new giving above existing giving. The pledges, along with a couple delays in spending, provided the basis for the proposed budget of 521,599; which is \$10,031/week or a 2.2% increase above the budget last year of \$510,599 or \$9,819/week.

We are grateful to the Lord for His provision, and the believers who support His work at College Church.

On the giving side, church finances involve the giving and resources of all of us who worship and call College Church their home. On the spending side, the stewardship, integrity, and wisdom of individuals and committees with spending authority is paramount. As mentioned last year, there are two individuals with detailed financial skills: Jan Goss as Financial Recording Secretary and Carol Anderson as Bookkeeper. Both exercise skill and knowledge in maintaining College Church giving and spending records with comprehensive documentation.

My greatest joy as treasurer is not the numbers of the budget, but working with many wonderful individuals and seeing the hearts and lives of people impacted and changed by the unconditional love of Jesus wherever we are along life's journey. We are a body of believers that seeks 'To Know Christ and Make Him Known'.

### **College Church Internal Audit Report**

For the fiscal year ended May 31, 2022.

The financial statements and records of College Church for the fiscal year ended May 31, 2022 and 2021 have been informally audited by an internal audit committee. The statements audited include the General Operating Fund Statements and Statements of Changes in Other Funds. It is the opinion of the audit committee that the financial statements and records of College Church are presented fairly and are free from material error.

The committee: Michael Jones (chair), Ann Satkowski, Bill Ruh and Connie Schwaiger

The initial step in this process was to compare the data in Quickbooks with the statements printed in the annual reports. The books tie accurately to the annual reports, with only small rounding differences (less than \$2).

The second step was to generate a random sample of outflows during the past fiscal year (1/1/2021 – 5/31/2022) as recorded in Quickbooks. For this, dollar unit sampling was used, with a layer amount of \$5,000, which generated about 100 sample checks for tracing and vouching. These 100 outflows were analyzed in order to confirm that for each check:

1. Payee on the check agrees with payee recorded on the books;

- 2. The signer is properly authorized to sign;
- 3. The memo in Quickbooks corresponds to an invoice or other documents;
- 4. The amount paid correspond to a purchase order or other invoice;
- 5. The invoice should be properly approved by someone other than the signer;

6. The check is shown on the bank statement;

7. The expense properly relates to our non-profit, ministry purposes;

We found that in nearly all cases there were no discrepancies in our random sample. The items that we flagged for possible discrepancies were all later confirmed or were immaterial.

- A recurring retirement contribution did not have an approval attached to it, but is clearly being correctly handled.
- We found one check for state tax withholding payments that differed from the invoice by an amount of seventeen cents.

In general, we found an amazing level of detail and evidence of thoroughness on the part of the bookkeeper and the treasurer. Memos recorded in Quickbooks correspond closely to the details of invoices, far beyond the level of detail required. Credit card statements have been carefully analyzed, with every item verified by the bookkeeper for proper authorization.

Our third step was to verify the accuracy of cash deposits. We chose a random sample of ten weekly giving statements and verified that the cash received agreed with the cash on the summary deposit statement and that the summary deposit statement agreed with the bank statement.

- We found one weekly giving statement that was not properly signed by the collection counters, but it
  was otherwise similar to other statements and we believe it was simply an oversight on the part of the
  counters. We recommend that if this happens again, the recorder should have the counters from that
  week sign a memo that confirms the collection statement.
- We found one weekly giving statement with the wrong date on it. It was otherwise normal.

Some of the financial activities of the church were beyond the scope of this audit, but they are of a nature that makes them all low-risk areas.

- SREC inflows
- Mineral Rights (the short term missions "oil fund") inflows
- Online giving inflows

As a committee, we have no concerns about the financial activities of College Church or the way books and records are being maintained. This audit process has given us an increased confidence in the financial integrity of the church.

### Introducing the 2023-2024 Budget

Our budget is a reflection of our vision and priorities. So what vision and priorities are reflected in this year's budget?

### **Children and Families**

Our budget includes funding for a new part-time Children's Ministry Director, the Summer Theatre Intensive, as well as retreat scholarships and contact work with middle and high school students.

### Making Disciples

Our budget includes funding for a new part time staff position at College Church: a Director of Whole-Life Discipleship and Community Formation, as well as GROW class materials and scholarships, and money for both staff and lay leadership training and development.

### **Global Impact**

15% of our budget goes to support our 22 gospel partners serving around the world! Our gospel partners share the love of Christ in over a dozen countries, through campus ministry, refugee care, health care, church planting, leadership development, Bible translation, youth work and more!

### **Stewardship & Hospitality**

God has blessed us with a beautiful property and wonderful facilities to care for, enjoy and share with others. In addition to housing many of our own ministries and events, each year we share our facilities with roughly two dozen organizations – including campus ministries, education collaboratives, youth sports as well as local arts and music groups. The Logan House continues to serve as the donation hub for Refugee Resettlement in our part of the world, and the Glass House and Logan House now host Recovery Church services, support groups and discipleship initiatives!

### Staff Care

As you know, inflation has been high in recent years. College Church has remained committed to providing annual Cost of Living Raises for our staff to keep pace with inflation. In addition, we began providing matching retirement contributions in 2022 for employees who work at least 20 hours per week.

### Prudence

Each year we have to find the sweet spot between funding the ministry we feel God is calling us to while living within our means. This year, we are grateful that we were able to fully fund our new staff position, and continue to fund our local and global mission while raising the overall budget just 2% over last year. This was made possible, in part, by the fact that we began setting aside money for new staff in 2021.
